SECTION 1

*Annual Guide provisions governing
eligibility and qualification for the District
and National Championship Tournaments*



DISTRICT PLAYOFFS AND NATIONAL CHAMPIONSHIPS

- **Youth Classifications**
(13 & 14, 15 Only, 15 & 16, 17 & 18)
- **Girls/Women’s Classifications**
(13 & 14, 15 & 16, 17 to 19, Women’s Senior A, B & C)
- **High School Classifications**
(Varsity and/or Prep School Divisions)

Each season, USA Hockey shall conduct District Playoffs and National Championship Tournaments in the Youth, Girls/Women’s and High School Age Classifications. The Rules and Regulations governing eligibility and qualification for the District and National Championships are set forth in this Article IX. The USA Hockey Youth Council shall approve a USA Hockey District and National Championship Tournament Guidebook, which shall be published and available on the USA Hockey website on or before September 1 prior to the following year’s District and National Championships. Except as set forth herein, to the extent of any contrary information in the USA Hockey Annual Guide, the District and National Championship Tournament Guidebook shall be the binding authority for the requirements, rules, regulations, operation and procedures of all USA Hockey District and National Championship Tournaments. For regulations applicable to regional, invitational and national championships for the Junior, Adult Men and Sr. Women (30 and Over, 40 & Over, and 50 & Over) classifications, please contact your appropriate registrar, the junior staff liaison, or the USA Hockey national office.

A. PLAYER AND TEAM REGISTRATION

All national tournament-bound teams and players (except Women’s Senior A) must be registered with USA Hockey and must be a member in good standing of an affiliate association on or before December 31 of the playing season. (Women’s Senior A teams must be registered with USA Hockey and be a member in good standing of an affiliate association by the third Monday in March). Teams competing on natural ice have until January 20 to register. Player changes to the official team roster for Youth Tier I and Tier II teams and girls/women’s national

tournament-bound teams will not be accepted after December 31. For games to count in meeting the 20/10 (14/10 girls/women's) rule, that team's official team roster registration form (1-T) must be certified by the appropriate district registrar or his/her designee prior to that game being played.

B. COACHING EDUCATION REQUIREMENTS

All coaches must have current USA Hockey certification and the corresponding online age-specific module to participate in the district and national championships. All coaches are expected and required to follow all USA Hockey rules, including the helmet rule, during all pre-tournament and tournament events. Non-compliance will result in a Discipline Committee hearing with a minimum one-game suspension. Please refer to the Coaching Education requirements, USA Hockey Annual Guide.

C. TEAM CLASSIFICATIONS

Youth/Girls

Within each Youth and Girls classification, the District and National Championships shall be at the Tier I and Tier II levels with eligibility to participate as follows:

Tier I: Any youth or girls team that is properly registered with USA Hockey as a Tier I national championship bound team.

Tier II: Any youth or girls team that is certified Tier II by an affiliate organization which has jurisdiction over the team. Tier II certification will be based on criteria set up by the affiliate and approved by the Youth Council.

If the affiliate rules permit a certified Tier II team to participate in the affiliate's Tier I district playoffs and a certified Tier II team elects to participate in that affiliate's Tier I district playoffs, then that certified Tier II team shall be ineligible to participate in the Tier II national championships.

High School Varsity and Prep School

Varsity Division (male and female teams): Pure teams that are community-based public high schools, private schools drawing their students exclusively from a local metropolitan area (excluding any school that boards players) OR a combined team from a state that has NO pure teams. Representation from each state will be determined by

the state affiliate participating in the tournament. Billed players competing on Youth Tier I, Youth Tier II or any junior teams are not eligible to compete in the High School Varsity national tournament. Participation is restricted to amateurs who are full-time students (grades 9-12), and 19 years old or under as of December 31 of the playing season. Eligibility is not to exceed eight (8) consecutive semesters starting with a player's freshman year. Clarification: Those high school students graduating mid-year are no longer full-time students and therefore, are not eligible to play on a varsity high school hockey team, effective on their last day of attending classes full-time.

Prep School Division (male and female teams): Boarding schools, non-community-based high schools and others. All teams, players and coaches must register with USA Hockey prior to application for participation.

For districts only, these rules and regulations may be modified for local and state association competition and districts that are composed of a single state, as conditions may require.

Player eligibility regulations may not be less restrictive than those governing national championships.

D. TOURNAMENT ELIGIBILITY AND REGISTRATION

- (1) Players and registered team members properly classified shall be eligible to participate in district and national tournaments see:
 - (a) Rules & Regulations; Section II: Classifications; Subsections Youth, Girls/Women, High School Varsity and/or Prep School
 - (b) Rules & Regulations; Section III: Team Membership and Registration.
- (2) The team shall be certified by its appropriate registrar (form 2-C, team roster registration certification) to have complied with all eligibility requirements.
- (3) A verification and affirmation that a review of each player's birth certificate has been completed by a district registrar

or his/her designee. When no verification and affirmation is provided, a copy of government issued birth certificate, verification of birth or copy of a passport identification page for each rostered player, is required. Also, for High School Varsity and/or Prep School divisions, evidence of current school enrollment eligibility to participate on the team is required.

- (4) The team's certified player roster must be in the hands of the championship director one week before the start of the championship.
- (5) The team and each rostered member must be eligible to participate in the district championships in order to participate in the national championships.
- (6) Number of Games for Eligibility – districts and nationals
 - (a) Each team must have competed as a team unit in at least twenty (20) games for youth teams, at least fourteen (14) for girls/women's teams except Women's Senior A and at least ten (10) games for High School Varsity and/or Prep School divisions, and
 - (b) Each player must have played in at least ten (10) games during the season or at least five (5) games for High School Varsity and/or Prep School divisions. Women's Senior A players must have played in the ten (10) games prior to the third Monday in March. Women's Senior A district all-star teams are allowed and may be composed of players having played in ten (10) games for a district team prior to the third Monday in March. This team will not be required to have played as a team prior to the nationals.
 - (c) For games to count in meeting the 20/10 (14/10 girls/women's, 10/5 high school varsity and/or prep school) rule, that team's player roster form (1-T) must be certified by the appropriate registrar or his/her designee prior to that game being played. Teams formed and certified prior to the September 1 season start may have games played in August counted toward fulfilling the 20/10 (14/10 girls/women's, 10/5 high school varsity and/or prep school) requirement, with approval

of the district registrar. Player changes to the official team roster for youth Tier I and Tier II teams and girls/women's national championship bound teams will not be accepted after December 31 (February 15 for High School Varsity and/or Prep School divisions). Any question regarding eligibility of game count in the girls/women's program would be resolved by a committee composed of the appropriate registrar, the appropriate district Girls/Women's Section Representative and the Girls/Women's Section Director. If the issue cannot be resolved, the team may appeal to a committee composed of the Youth Council chairperson, the Registrar Section director and the national championship director or their designees.

- (d) A game is a match played against another team which is registered with a member organization of the IIHF of the same competitive level and officiated by registered officials. A game shall consist of at least three (3) periods (or the equivalent, see paragraph R. Time of Periods below), except where the game is interrupted, (by some unforeseen event) after two (2) periods have been completed. High School Varsity/Prep School games played against school sanctioned teams and USA Hockey high school teams shall count as games toward the 10/5 rule.
- (7) **Ineligible Coach(s)/Player(s):** Any coach of a team that knowingly plays an ineligible player(s) shall be suspended from coaching in any games that lead to a district or national championship in the current hockey season.
- (8) **Appeal Procedure:** Should a youth level, girls/women's or high school varsity and/or prep school team, coach or player(s) be declared ineligible to compete by a final decision of the applicable Affiliate, District or Registrar in a district and/or national championship or playoffs leading to a district or national championship, the team, coach or player may appeal its ineligibility to the National Championships Appeal Committee, which shall be comprised of the Youth Council chairperson, the Registrar Section director and the national championship director or their designees. The National Championships Appeal Committee will add the

High School Section director in the case of High School Varsity and/or Prep School divisions. Upon receipt of the appeal the National Championships Appeal Committee will render a decision as soon as possible. The decision of this National Championships Appeal Committee shall be final.

E. NUMBER AND QUALIFICATION OF TEAMS

(1) Districts

- (a) The qualifying procedure and number of teams, and the entry of a host team, shall be determined by the district. The national championship director shall act as the final authority in all unresolved disputes.
- (b) The host shall be allowed an entry at districts, if permitted by the district or affiliate.
- (c) It is recommended that the national championship host team not participate in state or district playoffs.

(2) Nationals – Youth Tier I, Tier II, Girls/Women’s, High School Varsity and/or Prep School

- (a) The Youth Tier I and Girls Tier I National Championship Tournament shall include a total of 16 teams. The Youth Tier II, Girls Tier II, Women’s and High School National Championship Tournaments shall include up to 48 teams.
- (b) Where a program already designated to act as host for a national championship tournament elects to participate in its district playoffs and wins the district playoffs, the district playoffs runner-up team will be designated to represent the district in the national championship. The host team must participate in the host position in the game format at all national championship tournaments, unless specifically approved otherwise.
- (c) No team representing a district shall be ineligible from championship competition for reasons other than those found in this Article IX or in the National Championship Tournament Guidebook.
- (d) If, for any reason, there are less than twelve (12) teams qualified, the national championship director may select

a team or teams in order to operate the tournament successfully.

- (e) For a tournament to qualify as a national championship, at least three (3) districts and a host must be represented.
- (f) The Youth Council and the national tournament director have the discretion to operate a national tournament with any number of teams.

(3) Nationals – Women’s Teams Classification Movement

- (a) A Women’s Senior B or C team must move up from its present classification if it has won a women’s senior national championship in any of the last three (3) years and placed first or second in either of the two (2) other years. This includes teams of different program registration when a majority of the same players came from the same team.
- (b) When a women’s senior B or C team has qualified to move to the next highest classification in the next national championship and participated, the Girls/Women’s Section will review their ability to be competitive with the higher classification teams and make a recommendation to either have the team remain or move down a classification for the following season.

F. ENTRY FEES

(1) Districts

Fees should be determined by the cost of running the event. The fee shall be submitted and approved by the National Championship chairperson at least thirty (30) days prior to the District Championship.

(2) Nationals

Each team at all National Tournaments (Youth, Girls, Senior Women’s and High School) shall pay a tournament entry fee as determined by Section 2(J)(3)(i) of the National Tournament Guidebook.

G. NOTIFICATION OF INTENT TO ENTER TEAM(S)

- (1) Affiliate associations shall signify their intentions of entering a team(s) in the district at least sixty (60) days prior to the tournament.
- (2) A district shall signify their intention of entering a team or teams in the Girls Tier I, Youth Tier I, and Youth II National Championship Tournament, in writing, to USA Hockey with a copy to the Youth Council chairperson by October 15 of the current season. A district shall signify their intention of entering a team or teams in the Girls Tier II or Senior Women's National Championship Tournament, in writing, to USA Hockey with a copy to the Youth Council chairperson by November 15 of the current season. Affiliates shall signify their intention of entering a team(s) in the High School Varsity and/or Prep School National Championship Tournament by November 15 of the current season.
- (3) Once declared, the district/affiliate must compete in the national championships or be subject to a one-year suspension from future championship eligibility by the USA Hockey Board of Directors. The Youth Council shall:
 - (a) Notify the affected parties of the council's suspension recommendation at least thirty (30) days prior to the USA Hockey Annual Congress.
 - (b) Give the affected parties an opportunity, in person or writing, to explain the circumstances which caused the non-appearance.
 - (c) Include its decision in the council's report to the Board of Directors at its Annual Meeting.
 - (d) Participation in USA Hockey district and national championship play shall be at the discretion of USA Hockey affiliate associations, subject to rules with regard to notice, etc., as set forth herein. No affiliate shall be forced to participate, nor shall any of its constituent organizations have a vested right to participation, simply because USA Hockey does provide a national championship for which they may be eligible.
- (4) No USA Hockey member team or association may participate in any league that prohibits that team or

association from entering and fully participating in its state, district or national championship. All teams participating in that league shall not be eligible to participate in any state, district or national championship.

H. COMPLETION DATES

All district tournaments must be completed not less than fourteen (14) days prior to the first day of the national championships. Dates for national championships will be established by the Youth Council at the Annual Congress prior to the tournaments and announced at that time.

I. AGE CLASSIFICATIONS

(1) Youth

To be eligible to compete in District or National Championship Tournaments during the 2018-19 season, except as set forth in (3) below, a player must have been born during the year indicated below:

13 & 14	2004 and 2005
15-Only	2003 (in Tier I level only)
15 & 16	2002 and 2003
17 & 18	2000 and 2001

Note: The District and National Championships for the 15-year-old age category shall be for the Youth Tier I level only and shall be limited to players age 15 (as defined in the age classification chart for the current season). Players that are not age 15 in the current season shall not be permitted to play in the District or National Championships at the 15-year-old age classification under any circumstances.

(2) Girls/Women

To be eligible to compete in District or National Championship Tournaments during the 2018-19 season, except as set forth in (3) below, a player must have been born during the year indicated below:

13 & 14	2004 and 2005
15 & 16	2002 and 2003
17 to 19	1999, 2000 and 2001
Women's Senior	2000 or prior

(3) Participation in Older Divisions of District or National Championships – 2017-18 Season and Beyond

No player 12 years of age or younger (as defined in the age classification chart for the current season) is eligible to play

on a team intending or declared to compete in the District or National Championships or playoffs leading thereto except as follows:

For the 2018-19 and 2019-20 seasons for Girls 14U Tier II only, an Affiliate may permit up to 3 players that are 12 years of age for the current season (as defined in the Youth/Junior Age Classification chart in the Annual Guide) to be rostered on a Girls 14U Tier II team intending or declared to compete in the District or National Championships or playoffs leading thereto if the AFFILIATE finds that either:

- a. the younger player(s) are from the same local geographic area as the team they intend to play for and are needed to field a Girls 14U team with a roster size recommended by the ADM, or
- b. there is no 12U girls team available in the player's home local geographic area.

A player 13 years of age or older may play on a youth or girls team in an older classification at a District or National Championship Tournament only if the applicable Affiliate's rules or decisions, and the applicable local program's rules or decisions, permit that player to do so. A player residing in one Affiliate may not play on a team in an older classification in a different Affiliate unless both the Affiliate where the player resides and the Affiliate where the player desires to play have granted permission to play in an older classification. In the event a youth or girls player has been denied the permission to play in an older classification in the Youth or Girls District or National Championships on a team in an Affiliate other than the Affiliate where the player resides, the player may appeal such denial to the National Championship Appeal Committee. All other requirements, rules, regulations, operation and procedures of all USA Hockey District and National Championship Tournaments shall be set forth in the District and National Championship Tournament Guidebook.

J. REQUIREMENTS TO HOST A DISTRICT AND NATIONAL CHAMPIONSHIP TOURNAMENT

In order to be eligible to be awarded USA Hockey District/ Affiliate Tournaments, National Championship Tournament or coaching/officiating clinics, the host facility must be a United States Ice Rink Association member and register all of its ice hockey programs/leagues with USA Hockey. Exceptions can be granted with the approval of the appropriate council.

(1) Selecting A Host – Nationals

Application to host a National Championship Tournament shall be submitted on the official application form with the accompanying fee to the USA Hockey Youth Council staff liaison by June 1 two years prior to the national championship being applied for. The tournament host must agree to all of the rules and regulations of the national championships. This fee is nonrefundable to hosts who are awarded championships.

(2) Outside Web Facilitators – Nationals

All hosts are required to provide the necessary on-site web support to upload game results/statistics immediately following the conclusion of each game. USA Hockey owns and uses the “Official National Championship Tournament Tool” scoring system, which all host locations are required to use exclusively to post live scores, statistics, game information and standings from each game of the tournament. No other scoring system or data publication system may be used during this event, regardless of any other rink arrangements. Host will not permit any such information to be displayed on any websites other than usahockey.com without the expressed prior written consent of the National Championship Tournament chairperson and USA Hockey Executive Director. In addition, USA Hockey utilizes HockeyTV to broadcast games live. No other video streaming may be used during this event, regardless of any other arrangements. Tools such as LiveBarn must be disabled during the USA Hockey National Championship Tournament.

(3) District/National Requirements

- (a) A sufficient amount of ice time shall be provided to comply with the regulations which permit a maximum number of games per day per team. – See Appendix 1

- (b) Team room blocks at National Championship Tournaments will be available through the host as outlined in the Host Information Handbook. The room blocks shall remain available for teams to book rooms until 10 days prior to the start date of the tournament, at which point the room blocks may be released.
- (c) At National Championship Tournaments, the rules for staying in host hotels are as follows:
1. The host and the host team(s), as designated by the host, shall negotiate the terms of staying in host hotels and any fees they may be required to pay per the host contract.
 2. Local teams are defined as teams whose home rink is within a 100-mile radius of the tournament rink(s). If local teams choose to commute instead of staying in host hotels, the local teams shall pay a \$500 fee to the host. If a local team stays in hotels but does not stay in a host hotel, the penalty for the local team shall be \$5,000 for Youth, Girls and High School teams and \$2,500 for Senior Women's teams.
 3. For all other teams, a minimum of 75% of team members and staff on team roster (1-T) are required to stay in the host hotel(s) for the duration of the participation in the tournament and are required to book rooms through the host. The penalty for the teams that do not stay in the host hotel(s) will be \$5,000 for Youth, Girls and High School teams and \$2,500 for Senior Women's teams.
 4. For all above penalties, the involved Affiliate will be responsible to collect the monies and forward them to the Youth Council chairperson. Districts have the authority to require team members and staff to use a host hotel(s).
- (d) No transportation will be provided by the host. The host will provide teams with a list of agencies where rental vehicles may be obtained.
- (e) The host shall be required to arrange for medical personnel to be in attendance at all district and national

championship tournament games. At minimum, the host shall arrange for one (1) medical personnel for every one (1) sheet of ice of tournament play. Medical personnel shall be defined as: a certified athletic trainer, EMT, paramedic, or physician. The host shall also arrange for one (1) athletic trainer to be on site at all times to coordinate return to play decisions after an injury. An Emergency Action Plan is necessary in case there is a need for resuscitation or emergency transport. The host shall be responsible for providing information on additional medical care beyond emergency treatment at the arena, the cost of which is the responsibility of the player's team or parents. The on-site medical personnel must also complete: (1) Daily Injury Summary and (2) USA Hockey Injury Form (required for any player held out of play or who is referred to a physician/hospital for follow up care).

- (f) All television, internet and radio rights are the property of USA Hockey. The selling of these rights shall be negotiated through the national office.
- (g) Hosts are required to provide a room for each director attending their event. All directors/staff need to stay in the same hotel or in properties that are within walking distance of each other.
- (h) The host shall pay the USA Hockey Officiating Program a fee of \$225 per game, and provide the game officials with a hospitality room at the arena(s) at no cost. Other than these obligations the host has no further responsibility with respect to officiating. The officiating program will handle payment of game fees, hotel accommodations, transportation to the event site(s), shuttle service between hotel and rink site(s) and per diem expenses. This applies to all Youth, Girls, High School and Women's divisions of USA Hockey's National Championship Tournaments.
- (i) Each team at the Youth, Girls, and High School National Championship Tournaments shall pay a tournament entry fee not to exceed \$1,500 to the host no later than five (5) days prior to the start date of the tournament. If a team does not pay the tournament entry fee, the team is not eligible to participate in the tournament. The

host may not charge a gate fee and all spectators and participants may attend the tournament at no charge.

- (j) Each team at the Senior Women's National Championship Tournament shall pay a tournament entry fee not to exceed \$1,000 to the host no later than five (5) days prior to the start date of the tournament. If a team does not pay the tournament entry fee, the team is not eligible to participate in the tournament. The host may not charge a gate fee and all spectators and participants may attend the tournament at no charge.

Note: The host may lower the entry fee for its tournament if the lower entry fee is applied to all teams in its tournament.

K. CHAMPIONSHIP CHAIRPERSON AND TOURNAMENT COMMITTEE

(1) Districts/Affiliates

A USA Hockey District Director or his/her designee from the district/affiliate holding the tournament shall be named District/Affiliate Championship chairperson. The District/Affiliate Tournament Committee shall be comprised of the applicable District/Affiliate Championship chairperson and at least two other USA Hockey or Affiliate personnel from the Districts/Affiliates involved in the tournament.

(2) Nationals

The National Championship Tournament chairperson will be appointed by the Youth Council chairperson, who shall select a Tournament Director for each National Championship Tournament location. There shall be a National Championship Tournament Committee, comprised of the National Championship Tournament chairperson, Youth Council chairperson, and the chairperson of the USA Hockey Registrars Section, with responsibility for oversight of all USA Hockey National Championship Tournaments, and an on-site Tournament Committee responsible for oversight of each tournament location. The on-site Tournament Committee at each National Championship Tournament shall be comprised of the on-site Tournament Director and at least two other USA Hockey Directors or other USA Hockey appointed personnel as selected by the National Championship Tournament chairperson.

L. MANDATORY COACHES/MANAGERS MEETING AND TEAM PICTURES

(1) Mandatory Opening Meeting

An opening meeting for all teams participating in the tournament **shall be held** prior to the start of play at a time and place to be set by the on-site Tournament Director.

All participating teams are required to have a team representative. No one person may represent more than one team at this meeting unless prior approval is granted by the on-site Tournament Director. ***Failure to have a team representative present shall result in the suspension of the head coach, as listed on the team's official roster, from that team's first game of the tournament.***

(2) Mandatory Team Pictures

It shall be required that the full team roster attending the National Championship Tournament have a team picture taken at the event by USA Hockey's designated event photographer. The team manager shall be notified of the date, time and location of the team's designated team photo appointment.

M. SCHEDULES AND FORMATS

(1) Affiliates and Districts

- (a) The tournament format and schedule of games, including home and visiting team designations, must be set by the applicable Affiliate or District Tournament Committee and approved by the National Championship Tournament chairperson no less than thirty (30) days prior to the first game of the Affiliate/District Tournament. Any district tournament schedule with an odd number of teams participating shall be approved by the National Tournament chairperson prior to the tournament.
- (b) The schedule of games shall be sent to all qualified teams by email or electronic communication no less than ten (10) days in advance of the first game.
- (c) Anyone requesting a change in the schedule must notify the applicable Affiliate or District Championship chairperson within 48 hours of receipt. Unresolved matters shall be referred to the appropriate Council.

(2) Nationals – Youth Tier I, Tier II, Girls/Women’s, High School Varsity and/or Prep School

- (a) Schedules will be posted in the national championships section of usahockey.com. The game schedule format may be played Thursday through Monday or Wednesday/Thursday through Monday/Tuesday for Youth Tier I. Any deviation from these requirements must be approved by the appropriate council.
- (b) The Youth Tier I National Championship Tournament shall include a total of 16 teams, comprised of one team from each USA Hockey District sending a team, and at-large teams selected by a Youth Nationals Selection Committee established by the Youth Council chairperson and National Championship Tournament chairperson. The Youth National Championship Tournament Selection Committee evaluates and selects at-large teams using the following information: national rankings, head-to-head competition among teams and common opponents, league records, and other information at the discretion of the Youth National Championship Tournament Selection Committee. Teams at the Youth Tier I National Championship Tournament are seeded into their respective brackets based on seeding.
- (c) The Girls Tier I National Championship Tournament shall include a total of 16 teams, comprised of one team representing the host, one team from each USA Hockey District sending a team, and at-large teams selected by a Girls National Championship Tournament Selection Committee established by the Girls/Women’s Section chairperson and the National Championship Tournament chairperson. The Girls National Championship Tournament Selection Committee evaluates and selects at-large teams using the following information: national rankings, head-to-head competition among teams and common opponents, league records and other information at the discretion of the Girls National Championship Tournament Selection Committee. Teams at the Girls Tier I National Championship Tournament are seeded into their respective brackets based on seeding.

- (d) The Youth Tier II National Championship Tournament shall include up to 40 teams, comprised of one team representing the host, one team from each state declaring to send a team, and at-large teams selected by the Youth National Championship Tournament Selection Committee established by the National Championship Tournament chairperson. If at-large bids are necessary, the Youth National Championship Tournament Selection Committee will review the list of declared teams provided by Registrars at the Winter Meeting and select at-large teams taking different states into consideration each year so that there is a rotation of states represented as at-large teams each year. Teams and host team are listed based on the previous season's registration numbers in the state for the age classification. The teams are placed into three conferences (3A, 2A, 1A), with 3A being the highest number of registered players, 2A being the middle number of registered players, and 1A being the lowest number of registered players. Conferences may consist of 16, 12, or 8 teams depending on the number of teams declared. To create conferences with this number of teams, a team may be placed in a higher or lower conference at the discretion of the Youth National Championship Tournament Selection Committee. The Youth Tier II National Championship Tournament is not seeded and teams are placed into their respective brackets. When possible, the Youth National Championship Tournament Selection Committee will attempt to place teams into different brackets than teams from the same state, affiliate, district, and/or league.
- (e) The 2019 Girls Tier II National Championship Tournament shall include a total of 16 teams, comprised of one team representing the host, one team from each USA Hockey District sending a team, and at-large teams selected by a Girls National Championship Tournament Selection Committee established by the Girls/Women's Section chairperson and National Championship Tournament chairperson. The Girls National Championship Tournament Selection Committee will review the list of declared teams and

select at-large teams by evaluating the following criteria (in no particular order):

- A variety of different states/geographic areas represented as at-large teams;
- Competitiveness;
- The number of teams from each district/affiliate;
- Results of affiliate and district tournaments; and,
- Other criteria at the discretion of the Girls Nationals Selection Committee.

The Girls Tier II National Championship Tournament is not seeded and teams are placed into their respective brackets. When possible, the Girls National Championship Tournament Selection Committee will attempt to place teams into different brackets than teams from the same affiliate, district, and/or league.

- (f) The Senior Women's National Championship Tournament shall include up to 12 teams in each division, comprised of one team representing the host and one team from each USA Hockey District that declares a team by the declaration deadline. If additional teams are necessary in one or more divisions, the Girls/Women's Section will review the list of declared teams provided by Girls/Women's Section representatives and select additional teams utilizing registration numbers from the previous season. Team(s) will be selected by district, beginning with the district that has the highest Senior Women's registration numbers from the previous season and continue in descending order until any/all additional needs are fulfilled per division. The Senior Women's National Championship Tournament is not seeded and teams are placed into their respective brackets based on the Senior Women's district assignments for a 12-team format in the appendix. When additional teams are selected, the Girls National Championship Tournament Selection Committee will attempt to place teams into different brackets than teams from the same affiliate, district, and/or league.
- (g) The High School National Championship Tournaments shall include up to 48 teams, which may include a

host representative, as determined by the High School Section. The High School National Championship Tournament will be divided into three divisions, with Division 1, Division 2 and Girls separated and each Division competing for their own national championship. The tournaments will be held in the same place at the same time.

Following are the definitions to be used for each Division:

- High School/Prep School Division 1: Formal high school and prep school teams or non-varsity teams consisting of full-time students attending the same high school or prep school or full time students that are eligible to play sanctioned varsity sports at that school.
- High School/Prep School Division 2: Formal high school and prep school teams or non-varsity teams consisting of full-time students attending more than one high school/prep school.
- Girls High School/Prep Division 1: Formal high school and prep school teams or non-varsity teams consisting of full-time students attending the same high school or prep school or full-time students that are eligible to play sanctioned varsity sports at that school.
- Girls High School/Prep Division 2: Formal high school and prep school teams or non-varsity teams consisting of full-time students attending more than one high school/prep school.

Note: *The intent of the above descriptions is to make Division 1 the designation for “pure” high school teams and Division 2 for “combined” teams.*

Tournament eligibility requirements will remain the same with each Affiliate determining its representative for the tournament. To encourage the growth of “pure” teams, any Affiliate with Division 1 teams would have to send a Division 1 team to the tournament before being allowed a slot in the Division 2 Tournament. Besides meeting Division 2 team requirements, all Division 2 teams must play a regular season schedule in a high school league as a team and shall not be an all-star team formed for the purpose of attending the National Championship Tournament.

Any Affiliate with “pure” teams that cannot field a “pure” team for the Division 1 side of the tournament can petition the USA Hockey High School Section for a waiver of the Division 1 requirement. Waivers will be considered on an individual basis.

(3) Tournament Formats

(a) Requirements for All Tournaments

- An ice cut is required before every game and between the second and third periods except in the Youth 17 and 18 Tier I classification where the ice shall be cut between each period. This includes all round-robin, quarterfinal, semifinal and championship games.
- The recommended game slot length(s) are set forth in Appendix 2 and include all required ice cuts.
- All ice cuts shall be on the clock with a 12-minute count down.
- No team shall be required to play more than two (2) games per day, and no team shall be required to play a second game in one day against a team playing its first game on that day, except with specific written prior approval of the National Championship Tournament chairperson.
- There shall be a minimum of four (4) hours between games on the same day from the conclusion of the first game until the start of the second and twelve (12) hours between games played on consecutive days from the conclusion of the first game until the start of the second.
- No games may be scheduled to begin prior to 8 a.m. and no game may be scheduled to begin after 8 p.m.
- All championship games should be scheduled to end no later than 3 p.m.
- Team placement/seeding and schedule for all formats below will be provided by the National Championship Tournament chairperson.

Note: Only the National Championship Tournament chairperson may grant an exception to any of the above items.

(b) 6 Team Format (12 Game Slots)

- Two (2) conferences (American & National)
- Three (3) teams in each conference

- Teams play cross-conference
- Preliminary round games = 3 on Day 1, 3 on Day 2 and 3 on Day 3
- Total preliminary round games = 9
- Top 4 teams regardless of conference will advance to semifinals
- Semifinal games = 2 (played on Day 4)
- Third-place medals are presented to the losing teams of the semifinal games on Day 4
- All championship games should be scheduled to end no later than 3 p.m. on Day 5

(c) 8-Team Format (15 Game Slots)

- Two (2) conferences (American & National)
- Four (4) teams in each conference
- Teams play against all teams in their conference
- Preliminary round games = 4 on Day 1, 4 on Day 2 and 4 on Day 3
- Total preliminary round games = 12 (6 per conference)
- Top 2 teams in each conference advance to semifinals
- Semifinal games = 2 (played on Day 4)
- Third-place medals are presented to the losing teams of the semifinal games on Day 4
- All championship games should be scheduled to end no later than 3 p.m. on Day 5

(d) 10-Team Format (23 Game Slots)

- Two (2) conferences (American & National)
- Five (5) teams in each conference
- Teams play against all teams in their conference
- Preliminary round games = 6 on Day 1, 8 on Day 2 and 6 on Day 3
- Total preliminary round games = 20 (10 per conference)

- Some teams will play 2 preliminary round games in a day but always against a team that has also played that day
- Four (4) hours minimum rest is required between games on the same day
- Some teams may have an “OFF DAY” during the preliminary round
- Top 2 teams in each conference will advance to semifinals
- Semifinal games = 2 (Played on Day 4)
- Third-place medals are presented to the losing teams of the semifinal games on Day 4
- All championship games should be scheduled to end no later than 3 p.m. on Day 5

(e) 12-Team Format (25 Game Slots)

- Two (2) conferences (American & National)
- Four (4) Divisions of 3 team each = USA, Olympic (American), NHL and Liberty (National)
- Teams play cross-division within their conference
- Preliminary round games = 6 on Day 1, 6 on Day 2 and 6 on Day 3
- Total preliminary round games = 18 (9 per conference)
- Top 4 teams in both conferences will advance to the quarterfinal round
- A1 vs N4, N1 vs A4, A2 vs N3, N2 vs A3
- Quarterfinal games = 4 (Day 4 morning)
- Semifinal #1: Winner A1/N4 vs Winner N2/A3 (Day 4 evening – minimum of 4 hours rest)
- Semifinal #2: Winner N1/A4 vs Winner A2/N3 (Day 4 evening – minimum of 4 hours rest)
- Third-place medals are presented to the losing teams in the semifinal games on Day 4
- All championship games should be scheduled to end no later than 3 p.m. on Day 5

(f) 16-Team 5-Day Format (31 Game Slots)

- Two (2) conferences of 8 teams each (American & National)
- Four (4) Divisions of 4 team each = USA, Olympic (American), NHL and Liberty (National)
- Teams play against all teams in their division
- Preliminary round games = 8 on Day 1, 8 on Day 2 and 8 on Day 3
- Total preliminary round games = 24 (12 per conference)
- Top 2 teams in each division will advance to quarterfinals
- Quarterfinals: U1 vs O2, L1 vs N2, O1 vs U2, N1 vs L2
- Quarterfinal games = 4 (Day 4 morning)
- Semifinal #1: Winner U1/O2 vs Winner L1/N2 (Day 4 evening – minimum of 4 hours rest)
- Semifinal #2: Winner O1/U2 vs Winner N1/L2 (Day 4 evening – minimum of 4 hours rest)
- Third-place medals are presented to the losing teams of the semifinal games on Day 4
- All championship games should be scheduled to end no later than 3 p.m. on Day 5

(g) 16-Team 6-Day Format (31 Game Slots)

- Two (2) conferences of 8 teams each (American & National)
- Four (4) Divisions of 4 team each = USA, Olympic (American), NHL and Liberty (National)
- Teams play against all teams in their division
- Preliminary round games = 8 on Day 1, 8 on Day 2 and 8 on Day 3
- Total preliminary round games = 24 (12 per conference)
- Top 2 teams in each division will advance to quarterfinals
- Quarterfinals: U1 vs O2, L1 vs N2, O1 vs U2, N1 vs L2
- Quarterfinal games = 4 (Day 4 mid-day)
- Semifinal #1: Winner U1/O2 vs Winner L1/N2 (Day 5 mid-day)
- Semifinal #2: Winner O1/U2 vs Winner N1/L2 (Day 5 mid-day)

- Third-place medals are presented to the losing teams of the semifinal games on Day 5
- All championship games should be scheduled to end no later than 3 p.m. on Day 6

N. CREDENTIAL REQUIREMENTS OF TEAMS FOR DISTRICTS AND NATIONALS

- (1) The District Registrar or his/her designee shall verify each team's eligibility for District and National Championship Tournaments.
- (2) Team credentials must be submitted to the appropriate District Registrar at least ten (10) days prior to the start of national championships. The appropriate District Registrar shall determine the deadline for receipt of team credentials for District Tournaments.
- (3) The District Registrar or his/her designee will address any incomplete credentials at the Opening Coaches/Managers meeting.
- (4) The credentials for each team shall include the following items:
 - (a) For National Championship Tournaments only, a copy of the Team Roster Registration Certification Form (form 2-C) signed by the appropriate registrar or his/her designee.
 - (b) A completed Credentials Verification sheet (form 1-C) and a USA Hockey Certified Roster Form (form 1-T) created by the USA Hockey Registry.
 - (c) A verification and affirmation that a review of each player's birth certificate has been completed by a District Registrar or his/her designee. When no verification is indicated on the Certified Roster/Credential Verification sheet, a copy of the government-issued birth certificate or passport identification page for the rostered player, is required. Also, for High School Varsity and/or Prep School divisions, evidence of current school enrollment eligibility to participate on the team is required.

- (d) USA Hockey waiver and release completed for each registered participant and team manager only for those that did not register online at usahockey.com (not required for participants who have registered online at usahockey.com).
- (e) Sanctioned game scoresheets to verify compliance with the 20/10 minimum number of games for eligibility rule (14/10 girls/women's, 10/5 high school varsity and/or prep school) for each team and rostered player.
- (f) USA Hockey Consent to Treat form for each rostered participant and manager.
- (g) Coaching credentials for each coach at the level mandated by USA Hockey as shown on the official roster (Form 1-T), credentials verification report (Form 1-C), or required registration and coaching credentials generated through registration software, whichever demonstrates most complete and current information.
- (h) Non-U.S. citizens must meet proof of resident status eligibility and have a completed transfer from home country ice hockey federation (if required) as stated in Rules & Regulations II: Classifications, paragraph C, of the USA Hockey Annual Guide.
- (i) Other documents pertinent to team activities and player and coach eligibility and identification.
- (j) A copy of the Official Roster (1-T) for each team shall be available from the on-site Tournament Committee upon request from any of the participating teams. Should the on-site Tournament Committee become aware of, and subsequently determine a player(s)/Coach to be ineligible before, during or after the tournament, said player(s) shall be ruled ineligible to participate in any remaining games and the team using the ineligible player(s) shall be required to forfeit any games in which the player(s) participated and shall be required to forfeit all scheduled National Championship Tournament games by the Tournament Discipline Committee. Also, if it is proven that the coach or manager was aware of the situation, they shall be subject to suspension by the on-site Tournament Discipline Committee whom may also refer back to the appropriate affiliate or district for additional review and further suspension.

O. NUMBER OF PLAYERS

A maximum of twenty (20) players, including goalkeepers, shall be permitted to play in a game. The maximum number of players, excluding goalkeepers, shall not exceed eighteen (18). It is highly recommended that all teams arrive at the District and National Championship with two (2) goalkeepers qualified under the rules. Teams that are unable to arrive with a backup goalkeeper shall be permitted, with the approval of the appropriate registrar and then the on-site Tournament Director or his/her appointee, to use a substitute goalkeeper from a lower level (Tier I, II, then house/rec.) team within the same association, affiliate or district. Selection order should start with the same age classification (lower level team) first and if not available, then move to the next younger age classification (any tier, house/rec.). The backup goalkeeper shall only be permitted to participate in a game in the event of extenuating circumstances and with the approval of the on-site Tournament Director.

Note: The high school teams may roster up to 30 players.

P. UNIFORMS

All teams entered must be properly uniformed. All teams must arrive with two (2) sets of jerseys: a home (light) and a visitor (dark) jersey. No additional jersey will be allowed. The home and visiting teams are as determined in the applicable tournament schedule set forth in Appendix 1. Unless otherwise approved by the on-site Tournament Director, the home team shall wear light jerseys and the visiting team shall wear dark jerseys in all games. All players participating in a National Championship Tournament must properly adhere his/her nationals patch(es) on his/her jersey(s) in the designated area. The head coach will not be allowed to coach until his/her players have complied with this rule and are properly uniformed.

Q. TIME BETWEEN GAMES

(1) Districts

There shall be a minimum of four (4) hours between games from the conclusion of the first game until the start of the second played on the same day and twelve (12) hours on games played on consecutive days.

(2) Nationals

No team shall be required to play more than two (2) games per day, and no team shall be required to play a second

game in one day against a team playing its first game on that day, except with specific written prior approval of the National Championship Tournament chairperson. There shall be a minimum of four (4) hours between games on the same day from the conclusion of the first game until the start of the second and twelve (12) hours between games played on consecutive days from the conclusion of the first game until the start of the second.

R. TIME OF PERIODS (ALL STOP TIME IN MINUTES) AND ICE CLEAN REQUIREMENTS

**Round-robin games will utilize one (1) 5-minute sudden-death overtime period, then proceed to a shootout if a winner has not been determined. Games tied in quarterfinal, semifinal and championship rounds will utilize one (1) sudden-death overtime period equal in length to the third period, then proceed to a shootout if a winner has not been determined.*

- (2) Each team is permitted one time-out of 60 seconds, whether in regulation or overtime, per the USA Hockey Playing Rules.
- (3) During District and National Championship Tournament games, the ice shall be cleaned (a) for the Youth 17 & 18 Tier I classification, before each game and between each period, and (b) for all other classifications, before each game and between the second and third periods, and there shall be a two (2) minute rest period between the first and second period, including in the semifinal and championship games. Any variation must be approved by the National Championship Tournament chairperson.

- (4) All warm-ups, timeouts, and rest periods shall be placed on the game clock. All ice cuts shall be placed on the game clock with 12 minutes between periods and time remaining until next game for between games.
- (5) The referees shall enter the ice before the teams for every game with two minutes remaining on the clock. The warmup clock will start as soon as the referees have completed their safety checks, put nets in place and the ice resurfacers gates are closed.

S. PLAYING RULES

The official USA Hockey playing rules shall be used. No protests shall be permitted on the playing rules.

T. OFFICIALS

The three- or four-official system, at the discretion of the National Championship Tournament chairperson and National Referee-in-Chief, shall be used. All referees and linesmen shall be assigned by the referee-in-chief, or his/her appointee, of the district holding the tournaments. Neither shall be eligible to officiate in any games. All referees and linesmen must hold at least a Level 3 classification. The district referee-in-chief, or his/her appointee, shall be in attendance at all games to supervise officials. All referees and linesmen are required to wear only the USA Hockey crest, and/or national tournament patch, on their referee sweaters.

U. METHOD OF DETERMINING CHAMPION

(1) Overtime for Nationals (Recommended for Districts)

(a) Youth, Girls/Women's and High School Varsity and/or Prep School Preliminary-Round Games

1. All Games Played to a Winner

If the game is tied following regulation play, one five (5) minute sudden-death overtime period shall be played. At the completion of the third period, the tied teams shall receive a two (2) minute rest period. The teams will remain on the ice. The teams shall change ends. If the score is tied at the end of the five (5) minute sudden-death overtime period, there shall be a shootout. The winner of the shootout will be credited with one additional goal in the final score.

(b) Youth, Girls/Women's and High School Varsity and/or Prep School Quarterfinal, Semifinal and Championship Games

1. All Games Played to a Winner

If the game is tied following regulation play, one (1) sudden-death overtime period shall be played. At the completion of the third period, the tied teams shall receive a two (2) minute rest period. The length of the overtime shall be equal to the length of the third period and shall be sudden death. Teams shall switch ends at the end of the third period. If the score is tied at the end of the sudden-death overtime period, there shall be a shootout. The winner of the shootout will be credited with one additional goal in the final score.

2. Shootout Procedures

The shootout will be conducted as follows:

- A shootout is defined as a player attempting to score a goal and the opposing goalkeeper attempting to stop the shooter from scoring the goal.
- The referee shall call the two captains to the referee's crease to flip a coin to determine which team takes the first shot. The home team shall call the coin toss. The winner of the coin toss will have the choice whether his/her team will shoot first or second.
- All goalkeepers and all players from both teams listed on the official game sheet shall be eligible to participate in the shootout.
- The goalkeepers will defend the net they were defending in the 3rd period.
- Any penalized player whose penalty had not been completed when the overtime period ended or who receives a penalty during a shootout procedure is not eligible to participate in any portion of the shootout procedure(s) and must remain in the penalty box.
- The shootout procedure shall begin with five (5) different individual shooters from each team taking alternate shots. The players do not need to be named beforehand.

- The goalkeepers from each team may be changed after each shot.
- The players of both teams will take the shots alternately until a decisive goal is scored. The remaining shots will not be taken.
- If after the shootout, the shootout score is still tied, there will be a sudden death shootout.

3. Sudden-Death Shootout

The sudden-death shootout will be conducted as follows:

- A sudden-death shootout is defined as each team attempting a shot. Should one team be successful and the other team not, the successful team shall win the shootout.
- Teams will select their shooters to participate in any order in the sudden death shootout, whether or not they shot in the previous round. The last player in the first round of the shootout may be the first player in the sudden death shootout.
- Players in a sudden death shootout shall not be allowed to take another shot until four additional shooters have completed their attempts.
- All goalkeepers and all players from both teams listed on the official game sheet shall be eligible to participate in the shootout.
- Any penalized player whose penalty had not been completed when the overtime period ended or who receives a penalty during a shootout procedure is not eligible to participate in any portion of the shootout procedure(s) and must remain in the penalty box.
- The goalkeepers from each team may be changed after each shot.
- The official scorekeeper shall record all shots taken indicating the players, goalkeepers and goals scored.

(2) Process to Determine Quarterfinalists, Semifinalists and/or Finalists

- (a) During the youth and girls/women's preliminary rounds, each team will be awarded three (3) points for a win in regulation, two (2) points for a win in overtime or

shootout, one (1) point for a loss in overtime or shootout and zero (0) points for a loss in regulation.

- (b) Refer to the formats for tournaments set forth in Appendix 1 for information on home team designations in any quarterfinal and semifinal game.

(c) Youth, Girls/Women’s and High School Varsity and/ or Prep School – Tie-Breaking Rules to Determine Standings Position

If two or more teams have an equal number of points, their position in the standings shall be determined by the following tie-breaking rules listed below. If at any point during the application of the tie-breaking rules, any or all of the teams can be seeded higher or lower than the other teams, the seeded teams will be placed in their position in the standings and the tie-breaking process will begin at Step 1 for any teams that remain tied.

Note: If all tied teams have not played each other, the tie-breaking process will begin at Step 2.

The tie-breaker rules are as follows:

1. The results of only the head-to-head games played between the tied teams in the following order:
 - a. Most points earned.
 - b. Most total wins (whether in regulation, overtime and shootout).
 - c. Most regulation wins.
 - d. Differential — Subtracting goals against from goals for in these games, the positions being determined in order of the greatest surplus.
 - e. Quotient — Dividing the goals for by the goals against in these games, the positions being determined in order of the greatest quotient. A quotient involving dividing by zero(0) has higher standing than a quotient from dividing by any number other than zero. Where two or more teams have no goals against and the quotient tie breaker is required, the teams shall be ranked high to low in descending order of “goals for.”

- f. Most periods won — In the games played by each tied team, points will be awarded for each regulation period won (2 points) and for each regulation period tied (1 point). Positions shall be in the order of highest point total.
2. If after applying the formulas of 1 a, b, c, d, e or f the tie still exists, the results of all the games played by the teams tied in the following order.
 - a. Most total wins (whether in regulation, overtime and shootout).
 - b. Most regulations wins.
 - c. Differential — Subtracting goals against from goals for in these games, the positions being determined in order of the greatest surplus.
 - d. Quotient — Dividing the goals for by the goals against in these games, the positions being determined in order of the greatest quotient. A quotient involving dividing by zero (0) has higher standing than a quotient from dividing by any number other than zero. Where two or more teams have no goals against and the quotient tiebreaker is required, the teams shall be ranked high to low in descending order of “goals for.”
 - e. Most periods won — In the games played by each tied team, points will be awarded for each regulation period won (2 points) and for each regulation period tied (1 point). Positions shall be in the order of highest point total.
 - f. Quickest first goal — The team that scored the quickest goal in their preliminary round games shall be ranked highest.
3. If the above procedure does not break the tie, the teams shall use a shootout procedure as previously described.

Note: A team may go into the tie-breaking process having defeated another of the tied teams and still not advance.

Note: If a team forfeits any of its games, and becomes involved in any tie-breaking formula, the team that forfeited will not advance and all games played against the forfeiting team shall be recorded as 1-0 victories for all opposing teams.

See appendix for tie-breaking scenarios.

V. DISCIPLINE COMMITTEE

- (1) The Discipline Committee for each Affiliate, District or National Championship Tournament shall be composed of three (3) people and be appointed prior to the first game by the on-site Tournament Director. Its members shall not come from the same community. The referee-in-chief, or his/her appointee, shall not be eligible to serve on the Discipline Committee.
- (2) The Discipline Committee shall be responsible for deciding any action, suspensions or otherwise, to be taken against a player or team official to be served during the tournament in question. The Discipline Committee shall have full power to waive or increase the one-or two-game suspension imposed in Rule 404(b), Game Misconduct.
- (3) The Discipline Committee shall have authority to initiate action involving supplementary discipline against a player or team official whether or not it involves the playing rules; provided, however, that no suspension shall occur without first giving notice of the intended action and providing the opportunity for a hearing. If deemed necessary by the Discipline Committee, use of video in hearings is allowed but must be solely provided by the USA Hockey contracted vendor for that event.
- (4) There shall be no hearing for a game misconduct (or for player or coach suspension under Rule 401(b)) unless deemed necessary by the Discipline Committee. The Discipline Committee shall hold a hearing on any match penalty prior to the team's next game.
- (5) All actions taken by the Discipline Committee as a result of incidents occurring at the Affiliate or District Championship must be reported within five (5) days to:
 - (a) the Youth Council chairperson;
 - (b) the National Championship Tournament chairperson;
 - and
 - (c) the respective affiliate(s).

- (6) The National Championship Appeals Committee shall have the authority to review and take appropriate action on any incident in an Affiliate or District Championship. For any incident occurring in the last game of a team's, coach's or player's participation in an Affiliate, District or High School Tournament, and the team, coach and/or player is scheduled to participate in a National Championship Tournament, then the National Championship Appeals Committee shall have jurisdiction and be responsible for determining the team's, coach's eligibility and any suspension for the National Championship Tournament.
- (7) The National Championship Appeals Committee shall be the sole authority in determining the eligibility of the individual(s) for National Championship Tournaments.
- (8) All suspensions incurred in the course of the national playdown schedule (i.e., in state or district playoffs) shall be served during regularly scheduled games of the championship playoff schedule. In no case, may such suspension(s) be served in a game occurring outside the championship playoff schedule, by scheduling a game not included in the national playdown configuration and having the player sit out that game.
- (9) Affiliate, District and National Discipline Committee authority, and the National Championship Appeals Committee's authority shall be solely to determine eligibility to participate in the applicable tournament, and any discipline that may extend beyond the applicable Affiliate, District or National Championship shall be referred to the applicable Affiliate Association.
- (10) If a player receives a major penalty during a State, Affiliate, District or National Tournament, the Tournament Referee-in-Chief shall communicate with the Discipline Committee, and the Discipline Committee shall review the player's status to ensure compliance with Rule 411 (Progressive Suspensions) and shall impose any required suspensions thereunder.

W. DISPUTES/OPERATION OF TOURNAMENT

- (1) Pre-tournament disputes between the on-site Tournament Director, the host committee and/or the district referee-in-chief, shall be resolved by the National Championship

Tournament chairperson in consultation with the Youth Council chairperson.

- (2) After the commencement of the first game, the tournament referee-in-chief, in consultation with the National Referee-in-Chief, shall act as the final arbiter in all disputes involving the interpretation of the playing rules.
- (3) For any other decision, other than playing rules interpretation, with regard to the operation of the tournament (including zero tolerance, tournament play or conduct not in the best interest of hockey), the on-site Tournament Committee shall have the final authority to make the appropriate decision.
- (4) The on-site Tournament Committee, in all matters pertaining to tournament play, shall have the authority to adjust matters at any time in the best interests of the tournament and ice hockey in general.
- (5) The on-site medical staff will have the over-riding authority to determine if a player's injury warrants removal from the game and/or referral to the local hospital as outlined in Appendix 3.
- (6) The on-site Tournament Committee shall have the authority to exclude and/or limit the presence at or the use of any artificial noise-making devices, except for those required to control the play of the game.

X. MERCHANDISE AND AWARDS

(1) Districts

The host may supply championship and runner-up awards.

(2) Nationals

USA Hockey shall supply championship, runner-up and third-place trophies and/or awards. USA Hockey shall supply patches suitable for wearing on a jersey for each team participating in the youth and girls/women's championships. The Marketing department will present a merchandise proposal to the National Championship Tournament chairperson (30) days prior to the Fall Youth Council Meeting. The Youth Council will then determine its national championship tournament merchandise program.

- (3) No all-tournament teams shall be selected.

APPENDIX 3

INJURY/CONCUSSION RETURN TO PLAY POLICY

Each host site is required by USA Hockey to have medical personnel on site during the entire District and/or National Championship Tournaments. The on-site medical staff may consist of a combination of Doctors, Nurses, EMT's or Certified Athletic Trainers.

The on-site medical staff will have the over-riding authority to determine if a player's injury warrants removal from the game and/or referral to the local medical facility. If a player is referred to the local medical facility, and intends to return to play, the player must provide the on-site medical staff with a written release from the doctor who examined him/her and determined that the player was able to return to play.

No coach, team doctor, team trainer, parent or guardian may take responsibility for the player returning to the ice without the approval of the Tournament host's on-site medical staff. There will be no exceptions, even if a player's parents happen to be a doctor or other medical professional. Only the on-site medical staff can approve the players return to the ice.

This is the minimum standard to be followed for return to play following an injury/concussion. If state laws require higher standards of care then those state laws shall be followed.
